APPROVE SETTLEMENT AGREEMENTS:

Motion by Director Mueller; Seconded by Director Goolsby that the Settlement Agreements for violations of District rules as presented be approved as follows:

1. Brazco Development:

Settlement as agreed in the amount of \$5,500.00 for past years fees due for an existing non-exempt well for the period stated, which has been paid in full, be approved.

2. Country Oaks and South Hatfield Mobile Home Parks:

Settlement as agreed in the amount of \$1,316.00 to be paid in 12 Monthly installments of \$109.67 with the first payment due by December 31, 2013 and by the end of the month for the following 11 months thereafter.

Motion approved with all voting aye.

Motion by Director Felder; Seconded by Director Pyburn to reconsider the settlement offer for **Brazco Development** and amend the motion to add the following language to the Settlement Agreement:

Installation of an AWWA approved meter within 30 days and verification be submitted to the District; and further that during the interim, the well may remain in operation and estimated production fees in the amount of \$100.00 be paid for the 30 day grace period.

Motion approved with all present voting aye.

EXEMPT USE WELL REGISTRATION REPORT:

The Exempt Well Registration Report for the current period was reviewed. No action was taken.

DROUGHT MONITOR REPORT:

The Drought Monitor Report for the State of Texas was reviewed and discussed. No action was taken.

SET HEARING DATE FOR PERMIT APPLICATIONS:

Motion by Director Felder; Seconded by Director Goolsby that a public hearing to consider approval of permit applications be set for the next meeting of the Board of Directors on **Thursday**, **January 9**, **2014 at 4:00 p.m.** in the District Office and that the applicants be notified. Motion approved with all present voting aye.

AUTHORIZE LEGAL ACTION WITH REGARD TO VIOLATIONS OF DISTRICT RULES:

Motion by Director Felder; Seconded by Director Pyburn to authorize the attorney for the District to take enforcement action up to and including filing a civil suit for violations of District Rules. Motion approved with all present voting aye.

DISCUSS ADDITIONAL PERSONNEL FOR DISTRICT:

The Board discussed the creation of a field inspector position for the District and asked the General Manager to make appropriate inquiries with regard to actions and provisions required to add additional personnel and to create a job description for said position. No formal action was taken.

As there were no further matters to be considered, the motion to adjourn was made by Director Goolsby and seconded by Director Felder. All present voting aye. The meeting was adjourned at 5:55 p.m.
