



Notice is hereby given that the Board of Directors of the Brazoria County Groundwater Conservation District will hold a PUBLIC HEARING on applications for new well permits at 4:00 p.m. on Thursday, May 13, 2021 in the District Office, Court House West Annex, 451 N. Velasco Street, Suite 140, Angleton, Texas. An urgent public necessity exists requiring the District to alter meeting procedures due to COVID-19 pandemic. 
