Notice is hereby given that the Board of Directors of the Brazoria County Groundwater Conservation District will hold a PUBLIC HEARING on applications for new well permits at 4:00 p.m. on Thursday, March 11, 2021 in the District Office, Court House West Annex, 451 N. Velasco Street, Suite 140, Angleton, Texas. An urgent public necessity exists requiring the District to alter meeting procedures due to COVID-19 pandemic. The hearing will be conducted via audio and video conference call pursuant to Texas Government Code, Section 551.125, and as modified by the Governor of Texas who ordered suspensions of various provisions of the Open Meetings Act, Chapter 551, Government Code, effective March 16, 2020, in accordance with Texas Disaster Act of 1975 (see Governor's proclamation on March 13, 2020, certifying that the COVID-19 pandemic poses an imminent threat of disaster and declaring a state of disaster for all counties in Texas).
