## NOTICE OF PUBLIC HEARING MEETING FOR BRAZORIA COUNTY GROUNDWATER CONSERVATION DISTRICT August 11, 2022

**NOTICE IS HEREBY GIVEN** that the Brazoria County Groundwater Conservation District will hold a Public Hearing to take public comments on Thursday, August 11 at 4:00 p.m. at 111 E. Locust St. Suite 140, Angleton TX 77515. The purpose of the public hearing is to receive comments on the proposed adoption of Desired Future Conditions for the Gulf Coast Aquifer within Groundwater Management Area 14 in accordance with Section 36.108 of the Texas Water Code. The Board of Directors will conduct an open meeting immediately following the conclusion of the public hearing where the Board may consider adoption of the proposed Desired Future Conditions.

The proposed Desired Future Conditions for the Gulf Coast Aquifer within Groundwater Management Area 14 are such that the following conditions are desired:

"In each county in Groundwater Management Area 14, no less than 70 percent median available drawdown remaining in 2080 or no more than an average of 1.0 additional foot of subsidence between 2009 and 2080."

The other groundwater conservation districts included in Groundwater Management Area 14 are the Bluebonnet Groundwater Conservation District, Lone Star Groundwater Conservation District, Lower Trinity Groundwater Conservation District, and Southeast Texas Groundwater Conservation District.

Comments may be made orally at the public hearing or may be submitted in writing at any time until the end of the public hearing. Oral public comment is limited to 5 minutes per speaker and/or 30 minutes total for all speakers.
